COMPANY HISTORY

Infiniti Global is a minority-owned, small business, located in the Metro Atlanta area. We provide strategic project management resources throughout the United States, Canada, and the Caribbean. PROBLEM STATEMENT

A 365-day operation, with no weather exemptions, was needed to manage services on the ground in Atlanta, Georgia. Over 300 evacuees from hurricanes Irma and Maria were evacuated from Puerto Rico and the United States Virgin Islands. The community included parties with cancer and on dialysis. The federal government needed to get a vendor to manage over 600 Renal meals daily to multiple locations throughout the Metro Atlanta area.

SOLUTION

Infiniti provided vendor management and strategic project management services. We partnered with national restauranteur Golden Krust, and Dietian to create renal food plans. We worked with distributors to create multicultural and ethnic meals. This was low sodium, and low sugar meals.

RESULTS

A successful 2-year comprehensive project management included on-time deliverables, vendor management, health procedures, and consumer relations. We provided 365-day services including project managers, delivery managers, and Vendor management. We worked across agencies such as HHS, and the CDC, to ensure quality assurance measures met federal standards. In addition, we worked with government and community stakeholders, such as the American Red Cross to create a comprehensive outreach plan to the evacuees.
